

Health Requirement Information

2018/2019

1. Immunization records **MUST BE RECIEVED** before your child attends the first day of preschool.

- If your child is behind on their immunizations, your clinician must complete a written plan on a state immunization exclusion form that will bring him up to date. An updated record must be submitted at the completion of that plan.

2. The Center requires documentation of:

- Physical:
Exams must be completed annually. Per Colorado Childcare Rules and Regulations, any child who does not have a current physical within 30 days of expiration will NOT be allowed to come to school until a new physical exam has been completed.
- Blood Lead and Hemoglobin Test:
This may take place during a physical exam, or at Public Health. Public Health provides free blood lead and hemoglobin screenings. They can also provide immunization services upon request. Call to make an appointment at 486-2413.
- Dental Exam:
Exam *must be performed* by a dentist and must include preventative care.

****Please request that your provider fax your child's most recently completed physical exam form, immunization record, dental exam form and blood lead/hemoglobin test record to The Center as soon as possible.**

- Health forms for provider completion are attached, and may be faxed to (719)486-9992.

3. Submit new health forms promptly after your child's exams or blood tests.

4. Should your healthcare provider recommend a treatment plan as a result of a new medical or dental diagnosis, bring subsequent documentation from your provider of treatment received, including future appointment dates for follow-up.

5. Inform The Center of any new chronic condition or medication prescribed. We will assist you in filling out the appropriate paperwork that will allow us to assist with a plan to meet your child's medical needs.

6. If you do not have medical insurance please contact Lizz Holm (486-6923), Lisa Roeder (486-6928), or Jenny MascarenaZ (486-6925) at The Center for application assistance.

- Free and low-cost insurance options are available. Many clinics also offer sliding scale fees or will waive copays.
