# Parent - Teacher Conferences

Some preschools schedule meeting during the year to talk about your child's progress. These meetings provide a chance to talk about your child's social, language, and cognitive development. For many parents, this conference provides your first opportunity to sit down one-on-one with your child's teachers to talk about how things are going.

While teachers often have information and work samples to share, it's equally important for parents to share impressions of their child's school experience, and to have any questions answered.

**Here are some questions that might help set the tone for productive and positive conference:**

- What activities and centers does my child gravitate towards?
- Do you feel my child is meeting developmental milestones for his/her age?
- What sorts of things can we do at home to keep our child excited about learning?
- What sorts of reading activities so you recommend we do at home?
- What goals do you have for the classroom this year?

Did you run out of time? Most meetings are scheduled in 20 minute increments. It's often hard to fit it all in during one conference. IF you still have unanswered questions, follow up with a written note, or schedule a second face-to-face meeting. Develop a solid relationship with your child's teacher - consider it your homework for the year!!!!

## BUS EVACUATION DRILL



Our first bus evacuation practice drill took place in the back parking lot at The Center on Wednesday, September 18, 2019. 23 of our preschool bus friends participated in an emergency evacuation drill conducted on the bus your child was riding in. Drivers and monitors conducted the drill jointly as a team. The children followed instructions given by the driver.

The Final Rule requires three basic topics to be addressed in every drill:

- Ridership rules. Safe riding practices are taught to children. This is the most important lesson young children should learn about Transportation -related emergencies.
- Every Head Start drill should include discussion about, and more importantly practice in, safe and orderly evacuation from appropriate exits. Our preschoolers evacuated through the front door of the bus.
- Children are taught how to sit and slide out an emergency door, and are taught to go to a prearranged point about 100 ft. from the bus and to stay there holding hands with each other in a safety chain or buddy system.

**AFTER WE CONCLUDE THE DRILL:** We Thank and praise your children!

A total of three emergency evacuation drills must be conducted each program year.

# Dear Parents,

**PLEASE** remember that front office staff may be assisting other parents at drop off and pick up, please allow a few seconds for them to respond to the door buzzer. **PLEASE** only ring this once, we have noticed with families with more than one sibling that you are allowing them to each ring the bell and it creates a lot of unnecessary noise. **PLEASE** do not hold the door open or open the door for people waiting outside unless you know who they are, we will buzz them individually.

## **Child Find**

**Early intervention for children with special needs**

Every county in Colorado has professionals who are trained to evaluate children in a variety of areas, including cognitive functioning, physical functioning, hearing and vision, speech and language and social and emotional development. This service is referred to as Child Find. Evaluations are conducted by the Child Find team at no cost to parents.

Once the child find evaluation team, which includes the parents, has gathered sufficient information used to determine a child's eligibility for early intervention or preschool special education services, an Individual Family Service Plan (IFSP; birth to three years of age) or an Individual Education Plan (IEP; three to five years of age) is developed and services begin shortly.

Children under the age of six may be referred at any time for an eligibility determination for early intervention (ages birth to three) or preschool special education services (ages three through five).



