<u>Roll Call:</u> Maria called roll and determined that a quorum was present.

<u>Approval</u> of <u>Agenda</u>: Karen made a motion to accept the agenda. Anahise seconded. All were in favor with no one opposed.

<u>Approval of Meeting Minutes:</u> There were two meeting minute approvals. These minutes were September 17, 2019 and October 9, 2019, Anahise made a motion to accept the meeting minutes for September 17, 2019. Karen Seconded. All were in favor with no one opposed. Elizabeth made a motion to accept the October 9, 2019 meeting minutes. Karen seconded. All were in favor with no one opposed.

Parent Activity Fund: The Parent Activity has \$790.65. There will be a deduction next month of the 2 October dinners.

<u>New Business:</u> Mary Jelf came again as a visitor to the meeting to discuss the revised New Five-Year Grant.
