2020 Preschool Learn-to-Ski Program

We are once again offering the downhill Learn to Ski program at Ski Cooper this winter. This program is designed for *children who have never skied before,* and who typically would not have the opportunity to ski without this program. The program is for older preschoolers who will be going to kindergarten next year. **Children must have turned four years old prior to October 1, 2019.**

<u>Through our partnership with GOL! and donations from agencies in the community, all program costs are covered</u> <u>and families are not required to pay to participate</u>. Non-Head Start families are welcome to make donations to help cover the costs of their child's participation—but this is <u>not required</u>.

The program includes free transportation, ski rental, lunch, and ski lessons. All lessons will occur during our regular preschool hours on the assigned days in January 2020.

Our Learn to Ski Program will take place from January 14 to January 23. Boot and ski fitting will occur on January 9. Each ski day, we will leave The Center at 10:00am and return at 1:30pm. Head Start children will still be able to take the bus to The Center and will arrive back at The Center in time to take the bus home. Your child will need to be at The Center by 9:45am with sun screen applied, jacket, snow pants, mittens, hat, and eye protection. We prefer that children wear helmets to ski; we are hoping to procure helmets that would be available to borrow. The temperature must be 10 degrees or higher at Ski Cooper by 8:45am for us to ski.

Children will be staying on the small, beginner hill to ski. There may be an opportunity to ski the big hill on the last day, but the Panda Patrol ski instructors will make the final decision.

Here is an overview of the guidelines and enrollment process for this year:

- Enrollment packets are now available to be picked up in the front office. If you would like a packet sent home on the bus, please call 486-6925 to request this. <u>Completed enrollment paperwork must</u> <u>be received no later than December 17, 2019 at 5:30pm</u>. The program is limited to 20 children who have completed paperwork on that date. From the children with completed paperwork, we will select 20 students using a lottery in which we pull names from a hat.
- **Children must have proof of medical insurance.** We will make a copy of your insurance card when you bring in your completed enrollment packet. There is a short-term insurance policy we are aware of through Adventure Advocates that can be purchased for one month for \$18-\$39. Note that you MUST enroll before the end of December to have coverage in January. If you do not currently have health insurance, but would like your child to be eligible for the Ski Program, please stop by the front office to learn more about the Adventure Advocates policy.

The Center Early Childhood Programs - Policy Council Minutes - Meeting Date - November 5, 2019

<u>Attending:</u> Maria Perez, Karen Brungardt, Elizabeth Saunders, Teresa Haynes, Casey McGovern, Olivia DeVargas, and Anahise Shoukas

Not Attending: Fernando Luna Lopez, Claudia Robles, and Kelly Callahan

<u>Roll Call:</u> Maria called roll and determined that a quorum was present.

<u>Approval of Agenda:</u> Casey made a motion to accept the agenda. Anahise seconded. All were in favor with no one opposed.

<u>Approval of Meeting Minutes:</u> The minutes were for the October 14, 2019 regular monthly meeting. Analyse made a motion to accept the meeting minutes for October 14, 2019. Casey Seconded. All were in favor with no one opposed.

<u>Parent Activity Fund:</u> The Parent Activity has \$647.22. The dinner for October 14 meeting has not yet been billed, so it does not reflect on this balance yet. There will be a deduction next month of this month's dinners as well.

There were questions asked and the council understood that this is a working document. Casey made a motion to approve the Program improvement plan. Anahise seconded.
