    - Has Bright Start been in compliance with the insurance requirement of the most recent (2021-22) lease? Is it currently?

Yes, the Certificate of Liability Insurance has been included in this packet.

- Enrollment.
  - Has Bright Start been in compliance with the enrollment requirement of the most recent (2021-22) lease? Is it currently? Will plans for program expansion be in compliance?

We are currently compliant with this requirement as we are currently licensed for max capacity of 45 across 3 classrooms. If we do decide to expand toddler care with an additional classroom our new licensed max capacity would be 55.

- Alternate facility locations for short-term use, availability and estimated costs.
  - Has Bright Start identified any alternate locations that could meet its needs before establishing a long-term facility?

We have explored potential interim and alternative locations; however, we have not been able to find any.

- Has Bright Start determined that it can be operationally sustainable in a new location?

The analysis is currently in progress

- How soon would each alternate facility be available? (For renovation, move-in, and operation)
  - N/A
- Programming and new revenue streams.
  - What progress has Bright Start made in establishing new programs? (e.g., approvals for operation, # of enrollments, hiring)

Bright Start has evaluated expansion of additional toddler capacity; however, current cost analysis shows that preschool tuition is subsidizing toddler care at approximately 75% of the true cost differential.

As a result, we are not planning to open an additional toddler classroom until a long-term tuition model is approved that better aligns rates with the true cost of care and market benchmarks.

A proposed multi-year tuition plan is targeted for Board approval at the March 11 meeting. This model is intended to:

- Reduce cross-subsidization between age groups
- Move tuition closer to market value
- Improve overall operational sustainability
- Better position Bright Start for long-term facility transition
  - What revenue is estimated / received from these new programs?

Preliminary modeling indicated that opening an additional toddler classroom under the current tuition structure would not generate positive net revenue and would increase operational risk.

As a result, expansion has been paused pending approval of a revised tuition model that better aligns rates with the true cost of care.

While there is clear community demand, including a substantial toddler waitlist and staffing interest, Bright Start is prioritizing financial sustainability before launching any new programming.

- What additional costs are estimated / realized from these new programs?

The primary additional costs associated with opening the new classroom are personnel costs, program supplies, and food costs. There are no anticipated capital expenditures, as the existing space is already equipped with the necessary classroom furniture and equipment to support the new room.

- One-time grant opportunities sought & received.
  - What grants is Bright Start currently seeking? For how much? Over what time period? When is the expected notification and award date? What requirements for new programming/services is included (or general operations)?

Bright Start is currently pursuing grant funding for operational sustainability and facility transition planning. Specific award amounts, timelines, and requirements vary by grant and are being tracked internally. We are happy to provide updates on grants received, if desired.

- Which of these grants has Bright Start received?

We are currently in the early stages of launching the broader capital campaign for the new location and will share additional details once the campaign is formally underway. We are also exploring hiring a consultant to support campaign strategy and management.

- Audited financial statements.
  - Can you please provide your most recent three years of audited financial statements and the timeline for when your next audit will be available.

Bright Start is not currently required to undergo an independent financial audit under state or federal thresholds, and therefore does not conduct annual audits.

In lieu of audited financial statements, we maintain complete financial records, annual budgets, board-approved financial reports, and IRS Form 990 filings. As a nonprofit of our size, the Form 990 serves as our primary public financial disclosure document.

We have attached our last three years of Form 990 filings for your reference.

Feasibility analysis is ongoing and evolving.

- Estimated costs.
  - What is the estimated cost for acquiring / renovating / constructing at each location?
    - The analysis is currently in progress

- What are the estimated ongoing costs for operating at each location (e.g., utilities, maintenance)?
  - The analysis is currently in progress
- Partners.
  - What partners have you identified that are interested in collaborating with you on each location?

We do not have any official location partners at this time, but are still having ongoing conversations with many community partners..

- Contractors.
  - What contractors have you engaged to provide estimates? Do they have any limitations on their availability to start work?

We have met with the City to confirm that a Conditional Use Permit (CUP) and childcare licensing would be allowable at 210 E 10th Street.

We are currently determining which architectural firm to engage to develop preliminary drawings for both the 210 E 10th Street option and a potential new stick-built facility. These drawings will allow us to obtain more accurate construction cost estimates and model associated operating costs. Contractor engagement and scheduling discussions will occur once preliminary plans are finalized.

- Timing.
  - What is the expected availability for acquiring, renovating/constructing, and beginning operations at each location?

Timelines will vary by location and scope (renovation vs. new build). Based on preliminary discussions, we anticipate:

Site selection: Targeting May 2026 (acquired by July 2026)

Design and permitting: 6 months

Renovation or construction: Approximately 9-15 months depending on scope

Licensing and occupancy: Following completion of construction

Based on current projections, an end of 2027 transition remains feasible if a site is selected and acquired within the planned timeframe.
